1995/1996 Phase 4 training block of instruction ended on Feb. 26, 1996. The primary topics covered included the conversion to the Def. Tech. Bean Bag round for the Remington 870 shotgun, a two hour P.O.S.T. video on "Standardized Emergency Management Systems", and a Safety Equipment check. Twelve officers were unable to attend this training, their names are listed on page 3 of this report. In regards to viewing the video, 23 S.R.P.D. personnel have not completed the basic requirement for "SEMS". This includes the 12 officers who missed Phase 4 training.

Attached to this report is a 14 page document on the findings of the Equipment Inspection. This report is for your use. This report does not include the 12 officers who have not been through phase 4 training yet. Some of these areas have been corrected by replacing or fixing used or broken equipment. Some of these repairs are ongoing, along with the need to finish the other 12 officers. Three important areas of concern were noted:

First, 7 officers were using some unauthorized ammunition in their duty handgun. In 4 out of the 7 incidents, training ammunition was used to fill up a magazine. Two officers thought they had purchased proper ammunition, but had purchased the wrong brand by accident. The last officer, a reserve, had training ammunition in his speed loaders.

Second, was the Helmets. The list only shows officers who needed faceshields, brackets, or major repair completed. Another 20 helmets were missing numerous nuts and bolts from lack of being inspected regularly. On the total, approx. 50 percent of the helmets inspected would not have been effective if needed in a crisis situation.

OBJECTIVE:

The primary objective of this phase of training is to certify all SRPD Officers in the use of the Defense Technology 23 BR Bean Bag round. The other segments of this phase of training are part of the advanced officer training update which is provided every other month during phase training. The two hour POST video, "Standardized Emergency Management Systems", is required for all SPRD personnel

LOGISTICS:

The morning session will be held at the Bullseye Range. We will cover the 832 PC handgun qualification course, a combat Low Light course of fire, and the Bean Bag training. The afternoon session will be held at the Crime Prevention Office. There we will conduct an equipment check, a short SDAT review on Nerve Stimulation Techniques, and a two hour POST video. An equipment list is attached for this phase of training.

INSTRUCTION:

A lecture will be given prior to each segment of instruction. This will cover both the background for the course, and an explanation on how the officer is to perform it. Two instructors are assigned for each class, with class size being set for ten officers per class.

PRACTICAL APPLICATION:

BULLSEYE RANGE: [Morning Session]

FIRST COURSE OF FIRE- [2 hours]

Defense Technology's 23 BR Bean Bag Round. [3 rounds] The lecture will include the nomenclature of the round, where it applies in the Level of Force, officer tactical considerations while deploying the shotgun, approved striking area's, and medical considerations after it's use. The officer will then fire one round from the 5 yard line, one round from the 10 yard line, and one round from the 15 yard line. The Primary Point of Aim will be **CENTER MASS BODY**. Def. Tech. lists the **Maximum Effective Range at 50 feet**. The suggested range is 20-45 feet. **It is not recommended to be used at less than five yards** unless the officer is given no other alternative by the subject. First this protects the subject from possibly receiving a severe or fatal injury. Second, it reinforces the officers training on keeping a safe distance from the subject until you are ready to handcuff them.

SECOND COURSE OF FIRE- [30 minutes]

832 PC Handgun Qualification Course. [36 rounds] A minimum passing score of 27 hits in the black is required.

THIRD COURSE OF FIRE- [2 hours]

A Low Light combat handgun course of fire. [50 rounds] Two officers at a time will be let into the firing range with all lights off. Three targets will be set down range per officer. One at the 7, one at the 10, and one at the 15 yard line. When the line is hot, the instructor will turn on his flashlight at the target he wants the officer to fire at. The officer will then draw their weapon, turn on their flashlight, and engage the target. The instructors flashlight will be turned off while the officer is firing. All shots are double tap. The officer will fire at an unknown number of suspects each time they fire. Each officer will shoot this course of fire twice. Multiple targets and the Failure Drill will be incorporated in this training block.

TESTING:

Each officer will be evaluated by the range staff during the Bean Bag course of instruction. Because SRPD has used the Remington 870 Shotgun for many years, this course of instruction is not expected to have any transition problems. The only change will be from the OO Buck round, to the Bean Bag round. The 832 PC Handgun Qualification Course is a mandatory pass / fail test. The Low Light combat course of fire is for training purposes only.

During the afternoon course of instruction, an equipment check of all police gear will be made. This will include Batons, Helmets [with case], Traffic Vests, Mouth guards, OC Containers, Ballistic Vests, Hobbles, and Duty Belts. We will also be showing a P.O.S.T. video in the afternoon.

COURSE OBJECTIVE:

TO TRAIN DEPARTMENT PERSONNEL IN THE PROPER HANDLING AND USE OF THE DEFENSE TECHNOLOGY 23 BR BEAN BAG 12 GAUGE SHOTGUN ROUND.

CLASSIFICATION / PHILOSOPHY:

ALTHOUGH THIS ROUND IS CLASSIFIED AS A LESS THAN-LETHAL ROUND, WE CANNOT DISMISS ITS POTENTIAL TO INFLICT SERIOUS OR EVEN FATAL INJURIES. THE OFFICER SHOULD AVOID FIRING THIS ROUND AT POINT BLANK RANGE, AND IS CONSIDERED HAZARDOUS IF FIRED AT RANGES LESS THAN 15 FEET. WHEN DISCHARGING THIS WEAPON AT LESS THAN 15 FEET, THE OFFICER SHALL AVOID SHOOTING ANYONE IN THE HEAD, NECK, SPINE, OR MAJOR INTERNAL ORGANS. THE RECOMMENDED RANGE FOR THIS ROUND IS FROM 20-45 FEET.

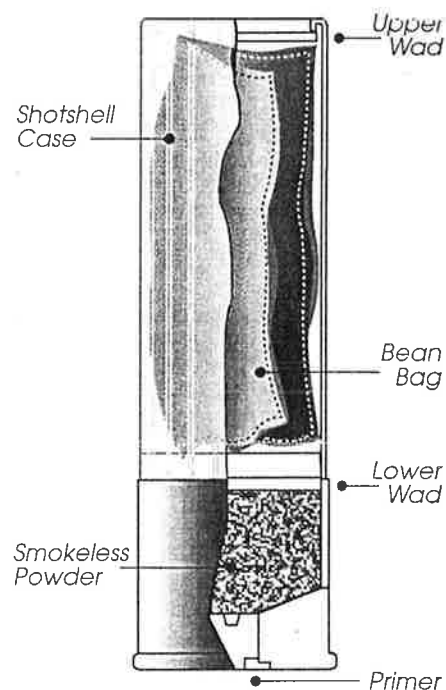

THE ROUND MAY BE FIRED DIRECTLY AT AN INDIVIDUAL BUT ONLY IN CIRCUMSTANCES WHERE JUSTIFICATION FOR USE OF FORCE IS MINIMALLY THAT NORMALLY REQUIRED FOR IMPACT WEAPONS (BATONS).

EXAMPLES MAY INCLUDE SITUATIONS WHERE AN INDIVIDUAL IS ARMED, RESISTIVE AND APPROACH TO BATON RANGE WILL RESULT IN A VIOLENT RESPONSE ENDANGERING THE OFFICER OR ANOTHER INDIVIDUAL INCLUDING THE SUBJECT. THIS WOULD INCLUDE SUBJECTS WHO ARE BRANDISHING STICKS, BOTTLES, KNIVES OR OBJECTS THAT COULD INFLICT SERIOUS INJURY UPON AN OFFICER OR OTHER INDIVIDUAL, OR WHERE AN INDIVIDUAL POSSESSES SOME PHYSICAL SKILL OR ABILITY (MARTIAL ARTS EXPERTISE) LIKELY TO RESULT IN INJURY TO AN OFFICER IN CLOSE CONTACT.

AS IN ALL USE OF FORCE SITUATIONS, THE OFFICER MUST ARTICULATE THE JUSTIFICATION.
