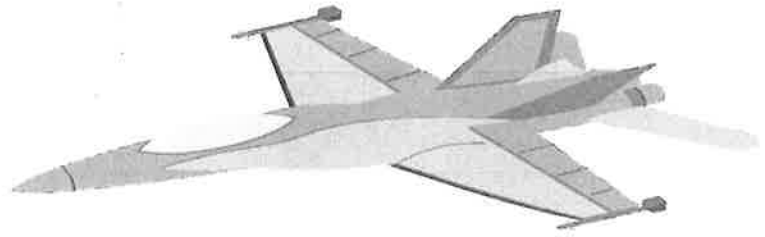

(SO. GARRARD TURNS INTO RICHMOND PKWY.)

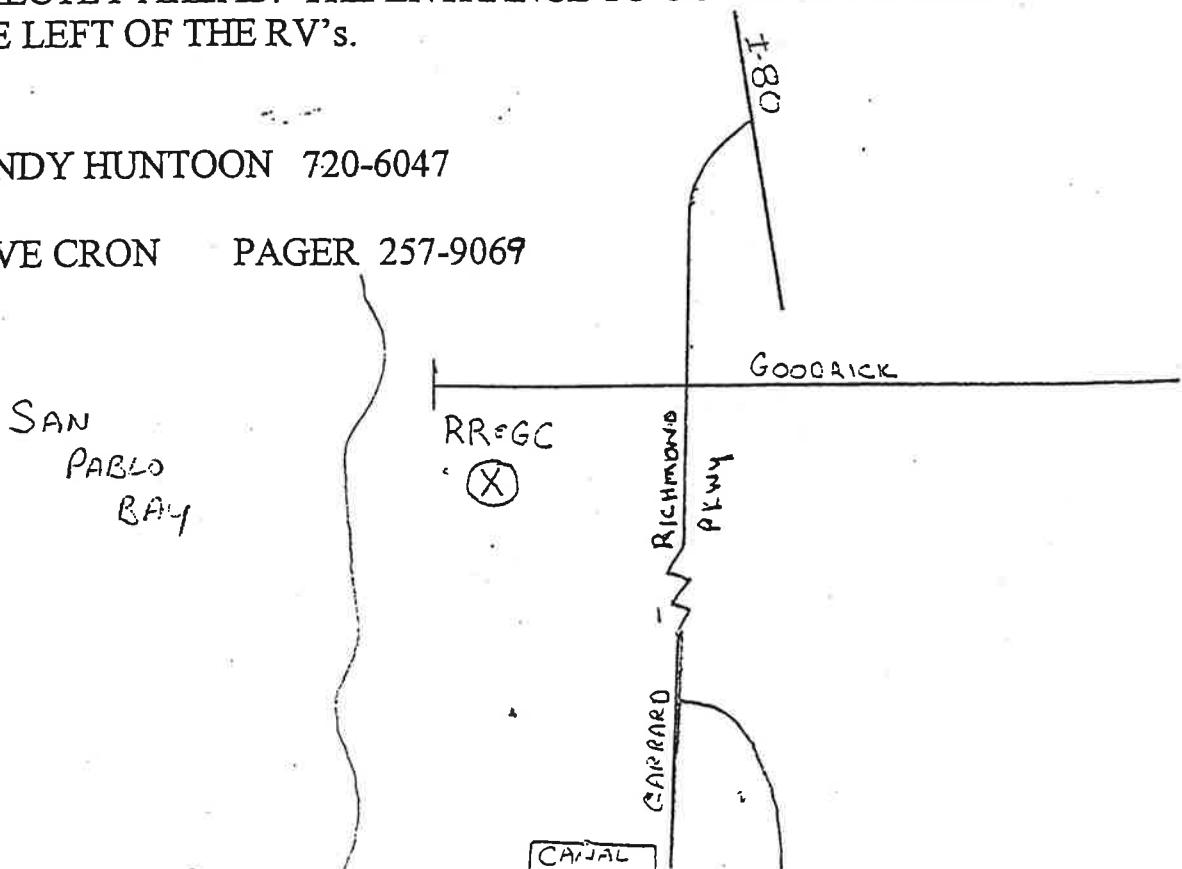
TURN LEFT ON GOODRICK

SUMMARY

The training unit has completed the Phase IV Training. The training consisted of qualifications for the handgun, rifle, and shotgun. The training was held at the Richmond rod & gun Club and City Hall at the Mall. The course consisted of a written test on G.O. 80-30 Discharge of a Firearm, lecture on cover and concealment, review of the rifle/shotgun inspection procedure, and a combat course. The combat course was structured so the shooter had to run to elevate his heart beat and then go through a course of fire utilizing doors and walls simulating a building entry. The shooter had to demonstrate good entry tactics, use of cover and concealment, movement, and good shooting skills. The training concluded with the POST video "Suicide by Cop-part 2".
