Officers were required to shoot a rifle qualification course from various positions such as, standing, kneeling, seated and prone. They also practiced shooting and moving with the rifles. The officers were wearing the ballistic helmet, tactical vest and personal body armor during qualification.

The second part of the day was spent at the SRPD Annex where officers participated in an active shooter drill. They walked through the annex as a team with an instructor explaining tactics and responses to an active shooter. After the walk through, officers practiced their skills in small teams responding to a simulated active shooter.

All personnel involved in the training completed the course in a satisfactory manner.
