The course was for patrol response to community violence. The classes consisted of various officers from different Marin County law enforcement agencies. The course was held at the College of Marin, Indian Valley Campus. It has been approximately six years since there has been county wide active shooter training. On the CD-Rom attached you will find the course presentation material and POST attendance record. There were a total of 15 sessions presented. The first session was on 12/10/07 and the last session was completed on 01/18/08.

Our training day started with the officers registering for the class and being given an overview of the day. After registration, a classroom presentation was conducted. The main focus for the class was to learn about the history of active shooter incidents, policy and procedures, and the mindset and tactics needed to combat such events in our community.

After the classroom presentation, the class was broken into teams of four officers. The teams were taken to an outside open area. Each team was led by an instructor in the team movements (T formation and Diamond formation) that would be utilized in an active shooter incident.

We reviewed and practiced the techniques used for searching and clearing hallways, entering rooms and moving as a team at hallway intersections. We also reviewed contact team techniques during an in-progress active shooter.

After the lunch break the training incorporated force on force scenarios with the use of Simunition equipment. The instructors discussed the reality of what can happen to an officer who is involved in an active shooter incident. There were a total of three scenarios incorporated into the lesson plan. The three scenarios were a mix of reaction drills and full scenarios.

The reaction drills were used to test the individual officers on the basic fundamentals of officer safety and tactical/critical decision making. An encounter with an armed suspect shooting at innocent students and a scenario involving two armed suspects were used to focus the officers on the 360 degree coverage of the team formation.

The full scenario was used to test and teach officers on the transition when the incident is no longer an active shooting. Officers were shown the recommended use of cover, team movement, communication, and use of deadly force and de-escalation of force. On the full scenario, there was a suspect holding a victim hostage. Not all the exercises were deadly force encounters.

There was no remedial training needed outside of the regular training day.

EQUIPMENT CHECK:

All officers had the correct equipment for training.

CONCLUSION:

A total of 235 officers attended and completed the training. All Marin County law enforcement agencies had officers represented. A total of 68 San Rafael officers attended and completed the training. Overall, each individual officer's effort and performance in this phase of training was very good. The feedback that I received from each class was very positive. The officers had high praise for the instructor staff, the equipment and the reality based training provided to them.

Numerous officers commented on the force on force training as being one of the best tactical and the most realistic training they have ever received. The instructor staff was very pleased to see that officers from different agencies were able to use the basic skills learned throughout the course of the day.

The multi agency training proved to be very successful and has added a new dimension to the officer's skill and knowledge level.

I submitted this training to P.O.S.T. for skills credit. The training was certified by P.O.S.T.


