Officer Survival Training

The Marin County Sheriff's Office (MCSO) and San Rafael PD co-hosted Advanced Officer Survival Training during July and August 2017. The training was held at College of Marin's Indian Valley Campus. This training focused on surviving volatile confrontations such as an ambush, armed kidnappers inside a vehicle, uncooperative patient at a party, an active shooter, and a high risk building search. To assist MCSO Deputies assigned to the jail, the uncooperative patient at a party scenario was modified to simulate an ill or injured inmate within a jail pod. MCSO held the P.O.S.T. certification for the course (4270-00300-16). A train-the-trainer day was provided to SRPD instructor staff on June 28th, 2017. Classes were then presented to the Deputies and Officers on July 12th, July 19th, July 27th, August 2nd, August 9th, August 16th, August 25th and August 30th.

MCSO took the lead role and coordinated with College of Marin PD to secure the training site. Additionally, MCSO provided air soft training weapons, safety equipment, a suspect vehicle for traffic stops and provided food for instructors and role players. SRPD provided Simunition gear, role players (cadets/records personnel), and patrol cars. The training was presented to Deputies and Officers from the Marin County Sheriff's Office, San Rafael PD, Ross PD, College of Marin PD, and Fairfax PD.

50 sworn personnel were trained from SRPD.

A total of 201 sworn personnel were trained over the course of eight days.

PHASE TRAINING MAKE-UP:

The following sworn personnel did not attend training due to excused absences:
All of Command Staff was excused from training.

No phase training make-up day will be offered.

P.O.S.T. CERTIFICATION:

Each attending sworn personnel received a total of 8 hours POST training credit.

CONCLUSION:

A total of 50 San Rafael PD Officers were trained in Advance Officer Survival. The training tested Deputy's and Officer's responses to high stress situation. Additionally, the training allowed for inter-agency cooperation. MCSO entered all of the POST rosters into EDI. A copy of each roster was placed into SRPD's training folder for reference.
