Dave, per our conversation on 1/13/98, I am writing this memo so you can have a record of the equipment that Tony and Dan have purchased for the SRT van. This equipment is for all of us to use in a mutual aid call-out. After you left, we agreed to spend the remaining approximately \$17,000.00 on two more night vision goggles, and the video camera for entry use. The video camera is \$7,400.00, and the two night vision goggles will cost \$4,000.00.

Dan mentioned to me that the SO is currently having two dispatchers sent to "Tactical Dispatch school" so they will be ready to go with the van on a call-out. Tony said that they have already sent a dispatcher to that school, and both requested that we do the same, at least with one dispatcher. I told them that I would bring that request back to you and Mike.

The Lash System radio headsets that we have been patiently waiting for are supposed to arrive by 1/21/98. This has been a priority, since our current radio headsets have been slowly falling apart. It sounds like they are state of the art, so I think this will take care of most of our radio problems. Below, I have broken down what has already been spent and the approximate costs of each item. Tony and Dan seem to think that the Task Force Oversight Committee would like us to spend all the money as soon as possible. They both think that after we spend all the money, and if we can justify the need for additional equipment, the committee will give us additional funding.
