On 8/5/18 at about 2105 hours, I overheard via radio San Rafael PD broadcast they were out with a subject to the rear of Burger King (969 Francisco Blvd East) who was non-compliant and armed with knives in his hands. At this time, San Rafael PD requested mutual aid to respond for assistance. I responded to this request and arrived in the area within a minute or two, followed shortly thereafter by Deputies and Sgt.  Upon arrival, I met up with San Rafael PD (SRPD) officers to the rear of Burger King near the intersection of Lisbon St and Verdi St. SRPD officers were attempting to negotiate with an agitated male subject pacing in the intersection holding a knife/bladed object in each hand. The subject was swinging his arms and repeatedly made stabbing motions in the air with the knives while SRPD officers attempted negotiate with him to put the knives down. The subject continued to pace back and forth in the intersection of Lisbon St and Verdi St refusing to put down the knives. I drew my department-issued firearm and provided additional lethal cover for the SRPD officers who had already deployed less lethal shotguns. I took up and maintained a position near the driver's side of a SRPD patrol vehicle parked to the rear of Burger King at Lisbon St and Verdi St. for several minutes as SRPD officers continued to negotiate with the male subject.  Deputy met up with me moments later at the above location. I communicated with SRPD Sgt. who was just to my right, on the other side of the patrol vehicle I was standing next to. I let him know I had with me and asked if he could be used at another location on the perimeter. Sgt. saked to meet up with Officer MacDougald near the intersection of Verdi St and Belvedere St. Deputy immediately went to that location and met with Officer MacDougald.								
Sgt who had also arrived, began coordinating a perimeter around the area using incoming law enforcement resources. Deputy arrived and with the assistance of Sgt. evacuated bystanders and assisted in clearing out the nearby Burger King restaurant which was still open for business (See Sgt. and Deputy supplemental reports for further).								
After several minutes of trying to reason with the subject, he began to walk away from officers/deputies at Lisbon and Verdi St down Verdi toward Belvedere St. At this point, I repositioned myself in order to possibly maintain visual contact with the subject as he walked away. Due to the ambient lighting conditions, I briefly lost sight of the subject as he continued to walk away from me toward Belvedere St. (toward Deputy and Officer MacDougald). Moments later, I heard someone yell, "Less Lethal" multiple times along with what sounded like four shots. I, immediately, began to run toward Belvedere St in order to assist. While running, I heard approximately three louder shots from the same location and saw the subject collapse to the ground on his back near the intersection of Verdi and Belvedere St. I got to the subject within seconds, who appeared to be gasping for air and groaning. I immediately secured the subject's right hand as it was unknown if the he was still armed and began rendering first aid with the assistance of Deputy Sgt. Sgt. and SRPD officers.

Narrative											
On August 5th, 2018, around 2105 hours, I was working as a Sergeant assigned to the Marin County Sheriff's Office. At this time, San Rafael Police Department requested assistance with an armed subject wielding a knife in the area of the Burger King off E. Francisco Blvd. in San Rafael. Deputies and I responded to the scene.											
Upon arrival, I made contact with Sergeant who requested I coordinate the perimeter and evacuation of surrounding areas while they negotiated with the suspect. Deputy and I started evacuating the nearby areas, which included Burger King, Lisbon Street and Verdi Street.											
While doing so, the subject was swinging his arms and repeatedly made stabbing motions in the air with the knives while Officers attempted to negotiate with him to put the knives down. The subject continued to pace back and forth in the intersection of Lisbon St and Verdi St refusing to put down the knives and making demands. The											

subject appeared agitated as he paced back and forth and swung the knives in the air in a stabbing motion.

During the course of the evacuations, I deemed additional resources would be needed and requested the California Highway Patrol assist. Five California Highway Patrol units responded and assisted with the perimeter surrounding the area where the negotiations were taking place with the subject.

After multiple attempts by San Rafael Police to reason with the subject and get him to drop the knives, he started to walk down Verdi Street and out of my view. I started to position myself to gain line of sight where the subject was walking when I heard someone yell, "LESS LETHAL" multiple times followed by approximately four shots. I then heard three more loud shots, which sounded like gun shots. I heard that shots had been fired over the radio and ran toward where the shots were fired. Sergeant immediately requested medical into the scene who was staged nearby.

On 8/5/18, at approximately 2105 hours, San Rafael Police Department requested mutual aid for a suspicious subject with a multiple knives to the rear of Burger King on 969 Francisco Blvd East in San Rafael.

I arrived on scene at approximately 2116 hours and provided crowd control assistance by clearing people out of the area to the rear of Burger King, the Burger King parking lot and drive through, and the alleyway adjacent to the Burger King. I also spoke with the manager of the Burger King and advised him to shut down the store at least until the situation was under control.

After Sgt. and I had cleared the area of pedestrians, I returned to the Burger King parking lot where I could see the suspect pacing back and forth on Verdi Street with what appeared to be a knife in each hand. I could hear one or more SRPD officers talking to the suspect and trying to get him to drop his weapons. I could not understand what the suspect was telling them, but it was clear that he was not complying with their requests.

After several minutes, the suspect began walking up Verdi Street towards Belvedere Street with the weapons still in his hands, and I began making my way up the street behind the suspect from a distance. Due to obstructions in my way I was unable to track the suspects every step, but I could hear commands being shouted. Shortly after I heard approximately four loud bangs with someone shouting: "Less lethal!" several times. This was followed by approximately three or four other loud bangs.

As the loud bangs were occurring, I began sprinting towards the intersection of Verdi Street and Belvedere Street to assist. When I arrived at the intersection I observed the suspect lying on his back and Deputy at his right side administering first aid. I put protective gloves on my hands and assisted with the first aid at the suspects left side. I maintained control of the suspects left arm with one hand, and with the other I located a
