Detective Anthony Diehm: It is August 6th, 2018 at approximately, uh, 3:07 a.m. This is in reference to San Rafael Case No. SR18-6261 and Sonoma County Sheriff's Office Case No. 180806-002. This is, uh, VCI Detective Anthony Diehm, um, and if everyone at the table could just introduce themselves, starting with my partner.

Detective Ryan Mitchell: Detective Ryan Mitchell, Violent Crimes, Sonoma County Sheriff's Office.

Deputy Jaime Rodarte: Deputy Jaime Rodarte, Marin County Sheriff's Office.

Detective Anthony Diehm: And, uh, this is also in reference to an officer-involved shooting in San Rafael. Uh, the deputy, uh, Rodarte, uh, was a witness officer. Um, Deputy, could you tell us, about your current assignment?

Deputy Jaime Rodarte: Sure, I'm assigned to patrol division. Have been so for the last 2 1/2 years, approximately.

Detective Anthony Diehm: Okay, and, uh, on this evening, uh, that we're talkin' to you about, was, uh, were you working your normal assigned shift or was it, like, an overtime shift?

Deputy Jaime Rodarte: Normal -

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: - assigned shift, correct.

Detective Anthony Diehm: Normal patrol shift?

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: Okay, and what are the hours of that shift?

Deputy Jaime Rodarte: Uh, 7 p.m. to 7 a.m.

Detective Anthony Diehm: Okay, and, uh, on that patrol shift you wear, you were, normally wear the uniform that you're currently wearing?

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: Which is a tan top and brown bo, bottoms?

Deputy Jaime Rodarte: Uh, green bottoms.

Detective Anthony Diehm: Or, green bottoms.

Deputy Jaime Rodarte: Yes.

Detective Anthony Diehm: Excuse me, sorry. Um, could you tell me about your training and experience?

Deputy Jaime Rodarte: Well, I went to the typical police academy in Napa, um, in 2000 and, uh, '04, 2005, uh, our custody division, um, a total of thir, uh, 12 year, 11 years prior to coming out to, um, patrol. I have specialized training in gangs, um, and classification, um, -

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: Yeah.

Detective Anthony Diehm: So you've been on patrol for how long?

Deputy Jaime Rodarte: A little bit over 2 years, I believe.

Detective Anthony Diehm: Okay, and have you tal, you've been to, it sounds like gang training and -

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: - what else?

Deputy Jaime Rodarte: A gang classification OIC and then the regular, -

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: - uh, bi-monthly trainings that we have here for firearms, um, CIT, I mean, the, -

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: - the common stuff that -

Detective Anthony Diehm: Do you have any cu, uh, collateral assignments, like, uh, -

Deputy Jaime Rodarte: Uh, -

Detective Anthony Diehm: - SWAT, HNT,

Deputy Jaime Rodarte: No.

Detective Anthony Diehm: - like, uh, -

Deputy Jaime Rodarte: Uh, HNT, yes.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: I was just selected for HNT.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: Um, still haven't been certified or sent to any training, but I've just been selected for HNT within the last few months.

Detective Anthony Diehm: Okay, and part of your training, does that include, like, uh, training with, uh, less, less-than-le, -lethal, -

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: - uh, weapons?

Deputy Jaime Rodarte: Yes.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: Part of our rifle and firearms training.

Detective Anthony Diehm: Okay. What, what are the, uh, less-than-lethal options that you carry on you or in your patrol vehicle?

Deputy Jaime Rodarte: A less-than-lethal, uh, Remington shotgun with the, uh, sandbag, uh, X26 Taser, and, obviously, baton and, uh, OC.

Detective Anthony Diehm: Okay. Um, in regards to the incident this evening, wha, uh, what I'm gonna ask is that, that you just give us a narrative of, uh, what happened tonight, uh, you know, what time you came on duty, and then how you ended up, uh, whatever the circumstances led up to you being at the scene or going to this call, and then just, just walk us through with, -

Deputy Jaime Rodarte: Okay.

Detective Anthony Diehm: - uh, what happened and what you witnessed.

Deputy Jaime Rodarte: Uh, today's date or yesterday's date, I, um, uh, got ready around, um, 1830 hours, got dressed out of the Kentfield substation, um, eh, took a couple calls for service for parking complaints, then I was asked by a sergeant to, uh, cover the southern Marin area, 'cause the units were tied up in the southern Marin area with, uh, priority calls. I went to southern Marin for about an hour and a half maybe, uh, grabbed some food at In and Out prior to comin' back to my, uh, original beat, which is Kentfield. Um, when I was on 101 northbound, I heard dispatch, uh, advise our sergeant that San Rafael had a, uh, incident that m, that may, uh, request that, that they may, uh, there, they could possibly request our assistance. Um, he acknowledged, the sergeant acknowledged the, uh, you know, the radio traffic and then shortly, I'd say within 2 minutes, dispatch came on the air and said, uh, you know, San Rafael is requesting additional units to respond. Uh, at that point I didn't know what the call was actually about. I just respond to the area, um, behind Burger King. I'm not sure of the address exactly. Uh, I arrived on scene within a few minutes of being dispatched, uh, saw another one of my, uh, Marin County partners parked next to a San Rafael unit, um, he was on the driver's side, um, I can hear San Rafael giving commands to a subject who is directly in front of him, uh, shadowboxing with knives. My partner asked me to hold his position for a few seconds while he gathered somethin' from his vehicle or gathered somethin' from some other area, uh, came back within a few seconds, and then asked me if I can hold, uh, hold, hold, uh, you know, uh, my position at a different location where there's only one officer, so I did. I went over, uh, to the second position where it was just me and a San Rafael unit. Um, from that, from that position I could see the subject in question, um, again shadowbox with some knives, they were givin' him commands, as far as put the knives down, uh, you know, what are your requests? That went on for approximately, I don't know, 15, 25 minutes. Um, at a couple times during the interaction with the officer, I saw the subject put the knives down on the pavement and then, but quickly picked 'em back up. That officer that was speakin' to the subject, uh, did come over the radio and say that the subject, um, was requesting that, you know, law enforcement shoot him, that he had a problem with the government, that he wanted a flight to Atlanta or somewhere out in the east coast, and, um, that the subject was not to leave the area because he posed a threat to, to the public. Um, like I said, after 35 minutes, I believe, ****, um, 35, 40 minutes of negotiating with the subject, he started walkin' in our direction, which was about a block distance. Um, there was several floodlights pointed in my direction, so I can see the subject walking towards me with, so I can see his silhouette. Uh, once he got within, I'd say, 20, 25 feet of my location, um, I had called out his name - 'cause I can hear the officers callin' out Ali - I said, I just, he was comin' at me, I told him, Ali, stop several times, stop, stop, I don't wanna shoot you, um, you know, and he kept comin' at me, and I yelled out less lethal several times, um, and shot him approximately four times with less lethal. I believe I made contact each, each time that I shot him. Um, the first one stunned him a little bit and then he kind enra, it kinda woke him up and he got up a little quicker. I shot him again, um, then he started chargin' at me, uh, mumbling and sayin' something, yellin' somethin' at me, and at that time he was, uh, closin' in on me. I'd say at that point he was 10, 15 feet from me with a knife over, uh, shoulder and, uh, I knew that I had officers downrange and I didn' wanna, uh, transition to my lethal 'cause of the people comin' towards my direction, so, as he's coming towards me, I try to break the angle so I can shoot from a different angle when I knew I had my partner on the right who's, had lethal. Um, as he, I'd say he got within 10 feet, 8 feet of me, a San Rafael officer - I forget his name - um, shot him, uh, multiple times and then he fell to the ground and we rendered first aid.

Detective Anthony Diehm: Okay. So, I'm gonna go back a little and just ask a few follow up

Deputy Jaime Rodarte: Okay.

Detective Anthony Diehm: - clarifying follow-up questions. When that initial part, at the beginning when you were told - well before that, at what point did you deploy the less lethal?

Deputy Jaime Rodarte: When I got to the second post.

Detective Anthony Diehm: Okay. So, when you first got at the scene.

Deputy Jaime Rodarte: I had just my regular firearm because -

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: - I, I believe I saw someone with less lethal so I just, I took out my firearm.

Detective Anthony Diehm: And when they asked you to move to the other scene where there was only one officer.

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: Um, did you walk to that location or drive?

Deputy Jaime Rodarte: I drove.

Detective Anthony Diehm: You drove?

Deputy Jaime Rodarte: Yeah.

Detective Anthony Diehm: And at that point, when you drove to that second location, um, at what point did you deploy your less lethal?

Deputy Jaime Rodarte: Uh, I talked to, uh, the Officer Shorlee, um, I said hey I got less lethal, you got lethal and he said okay so I we - went back to my car, I, uh, got the less lethal out.

Detective Anthony Diehm: Okay. And how far was this second scene from, uh, the active scene we have you initially responding to?

Deputy Jaime Rodarte: From my second location?

Detective Anthony Diehm: Yeah, how far was it from this other ****.

Deputy Jaime Rodarte: I, I, it's, it was a, exactly a block.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: So, whatever I **** to estimate, um, I don't know 60, I don't know 40, 40, 50 yards maybe.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: Yeah.

Detective Anthony Diehm: And from that location could you see – it sound, uh, it sounds like there was about a 35 or 40-minute window where you're at this second location.

Deputy Jaime Rodarte: Correct, yes.

Detective Anthony Diehm: While this is developing.

Deputy Jaime Rodarte: Mm hmm.

Detective Anthony Diehm: And from that location could you see and hear what was going on at the scene?

Deputy Jaime Rodarte: I'd say, uh, um, 80 percent I can hear and I can see most of it just because he was standing right in front of – he was standing right in the middle of the street and then there was a patrol vehicle with his fly lights on so it was, yeah, I could see what he was doing.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: When I – what I forgot to mention was there was people tryin' to cross the street so we were tryin' to do two things at once. We were tryin' to keep people from not crossing the street 'cause there was rifles pointed down range and a couple times I yelled at the crowd hey, there's rifles in this, in this, yanno, direct – there's rifles pointed in this direction. Um, I yelled it out in Spanish 'cause Canal is predominantly yanno, Hispanics, um, and, and, yanno, but I could see, I had a clear view of the subject who was down the street basically

Detective Anthony Diehm: Okay. And during that time, that 30 or, 35 or 40-minute window, um, did you see anything. I, uh, you went into it a little but, uh, can you describe anything that, uh, mighta concerned you in the moment or, or.

Deputy Jaime Rodarte: Absolutely, um

Detective Anthony Diehm: **** was at the forefront of your mind.

Deputy Jaime Rodarte: Yeah, he, uh, he was basically shadowboxing with knives going like this. Um, what I – he had, he had two objects in his hand, um, from the reflection of the lights I can see the, the, the, um, the shining coming off whatever metal object he had in his hand.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: And he was just basically, yanno, shadowboxing and, um, and, and that's when he told the officer who was talkin' to him that he wanted to be shot by law enforcement and that he had issues with the government and several other things that I can't recall.

Detective Anthony Diehm: And that – those statements by him, did you hear them or were they being broadcast over the radio?

Deputy Jaime Rodarte: Uh, they were being broadcasted over the radio.

Detective Anthony Diehm: Okay. And, were they broadcasting that he had knives, or could you just see that he had –

Deputy Jaime Rodarte: I, I could see the knives.

Detective Anthony Diehm: Okay, okay.

Deputy Jaime Rodarte: And I don't remember they were broadcasting that he had knives.

Detective Anthony Diehm: Okay. Could you describe the knives?

Deputy Jaime Rodarte: Um, I, initially obviously when, when he was about a block away I'd say it just looked like somethin' shiny. Um, when he came at me, um, when he finally dropped the knife after he was shot it was just like a folding knife.

Deputy Jaime Rodarte: And the other object was a pair of scissors.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: Yeah.

Detective Anthony Diehm: Um, when he – you described, uh, at some point, him advancing towards you?

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: Okay. Um, it sounds like it appeared to you that he, he saw and recognized that somebody was there.

Deputy Jaime Rodarte: Correct. He, he's, he's, he disengaged from the officers at the first site and he started walking down the, the street towards our location. Um, obviously there was patrol cars behind me, or, yeah, behind me and the other officer, um, I, like I said, I told him to stop. Ali, stop, Ali stop, I don't wanna shoot you

Detective Anthony Diehm: And that was like -

Deputy Jaime Rodarte: - and it's like he wasn't hearing me and just advanced towards me.

Detective Anthony Diehm: And he made no response that, uh, you recall acknowledging that -

Deputy Jaime Rodarte: No response at all, correct.

Detective Anthony Diehm: --your statements? And how far would you say he was when you fired the less lethal?

Deputy Jaime Rodarte: Uh, I'd say, uh, 20 feet approximately.

Detective Anthony Diehm: Okay. And that first, uh, round, you said that kinda woke him up?

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: Did it, did it knock him down or did it - what, how -

Deputy Jaime Rodarte: From what I -

Detective Anthony Diehm: - did he react ****.

Deputy Jaime Rodarte: - from what I recall as he, as he was walking down, um, he was mainly on the - if you're looking at him, on my left side -

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: - of the street. Once I hit him with the first one he kinda stumbled over to the right side, kinda took a knee and then immediately tried to get up again and then I hit him a second time, third time and a fourth time.

Detective Anthony Diehm: Okay, and did you have any cover, at that point when he was coming towards you?

Deputy Jaime Rodarte: Uh, initially when I shot him the first time I was - there was a, a, uh, Ford, uh, Escape I think, or Ford SUV and I was usin' that just because I was also concerned about someone possibly shooting down range. Um, but once I shot him the first time, I, I kinda advanced towards him a little bit just to see what he would do with the knives and, yanno, to see if he'd drop 'em or give up or quick cuff or, um, but he didn't do any of that and just got up

immediately, yelled somethin' out and then just started walking briskly or, um, well maybe even running towards me with the knife.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: Yeah.

Detective Anthony Diehm: And just – and just so I understand, you were positioned – can you explain to me how you were positioned behind this Ford.

Deputy Jaime Rodarte: Sure, can I show you with this?

Detective Anthony Diehm: **** how he was.

Deputy Jaime Rodarte: So, here, here, so, here's the street –

Detective Anthony Diehm: Uh huh.

Deputy Jaime Rodarte: - there's a vehicle here and a vehicle here, I'm standing here, my partner is standin' over here and this is the other street.

Detective Anthony Diehm: Yes.

Deputy Jaime Rodarte: Um, so when he, he's comin' down, he's comin' down this street – come out a little bit and I tell him to stop, stop.

Detective Anthony Diehm: Okay.

Deputy Jaime Rodarte: I don't wanna shoot you, stop. And then he, he ignored my commands, shoot him. He kinda stumbled back this way, it looked like he took a knee and then I kinda move towards the center at this point to get a better angle or a better shot at him and then that's when he got up again and, uh, said something and advanced towards me.

Detective Anthony Diehm: So, it sounds like there's vehicles parked on each –

Deputy Jaime Rodarte: On opposite sides of the street.

Detective Anthony Diehm: - side of the street.

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: And your positioned behind one vehicle –

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: And another officer's positioned behind another vehicle on the opposite –

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: - side of the street and he advances down the street between those two vehicles.

Deputy Jaime Rodarte: Correct.

Detective Anthony Diehm: Okay, um, did it appear that he saw the other officer to you – and if you don't know it's okay but –

Deputy Jaime Rodarte: Uh, I can't say.

Detective Anthony Diehm: - ****. Okay.

Deputy Jaime Rodarte: I can't say.

Detective Anthony Diehm: Um.

Deputy Jaime Rodarte: He was focused on me, uh, I can tell ya that for a certainty.

Detective Anthony Diehm: Okay. Um, anyway ****

Detective Ryan Mitchell: Had a couple things in – kinda hop around a little bit.

Deputy Jaime Rodarte: Okay.

Detective Ryan Mitchell: Um, uh, first just real quick, uh, the less lethal device that we're talking about, can you describe, uh, what that, what that is?

Deputy Jaime Rodarte: It's a Remington, um, can't remember the model number but it's a regular standard shotgun but uses beanbags instead of obviously slugs.

Detective Ryan Mitchell: Okay, so, it protects beanbags **** right?

Deputy Jaime Rodarte: **** yeah, correct. It's, it's, it's green in color as well.

Detective Ryan Mitchell: And does part of your training, that you've had before, include, uh, training regarding, um, uh, mental health and crisis situations?

Deputy Jaime Rodarte: Yes.

Detective Ryan Mitchell: Can, can you, uh, can you describe a little bit of what that training entails?

Deputy Jaime Rodarte: Sure. We, uh, we, we have CIT officers who are trained in that. Um, our last one was a few months ago. Basically, ya talk about case law, new, new veins, uh, resources for mental health patients, um, how to deal with them on a deputy level basically.

Detective Ryan Mitchell: Okay. And this, um, this suspect that, I believe you called him Ali, but –

Deputy Jaime Rodarte: That's what I heard the other officer call him, Ali –

Detective Ryan Mitchell: Okay.

Deputy Jaime Rodarte: - so I figure that that's –

Detective Ryan Mitchell: Okay.

Deputy Jaime Rodarte: - the name he gave him.

Detective Ryan Mitchell: Did, do you know him, ever seen him before?

Deputy Jaime Rodarte: No, not that I recall.

Detective Ryan Mitchell: And if you could describe what he was wearing and describe him, uh, to the best of your ability.

Deputy Jaime Rodarte: Uh, I can't really remember what he was wearing, to be honest with you.

Detective Ryan Mitchell: Okay.

Deputy Jaime Rodarte: Um, he was, yanno, um, brown complexion, um, I don't know maybe 5, 10, medium build, um, and that's all the, all that I can remember from him.

Detective Ryan Mitchell: And if you could describe his, um, mannerisms, I know you've mentioned he was shadowboxing. You, you, you held your hands up like you, you, you were boxing him.

Deputy Jaime Rodarte: Yeah, he had the knives in both hands as he was shadow, shadowboxing.

Detective Ryan Mitchell: Okay so he held 'em up, he held them up in front of him?

Deputy Jaime Rodarte: Correct. Like I said he's, he, he put 'em down a few times. I see him – I mean I could see him bend over and set 'em down and then he would immediately pick 'em up and then, yanno, that was also broadcasted over the radio that he put 'em down, but he just picked 'em back up.

Detective Ryan Mitchell: And was – how was his, uh, volume of voice?

Deputy Jaime Rodarte: At sometimes it was low and then it was high. Um, I, I do remember call, uh, hearin' him say, yanno, you're full of shit or you're bullshitting me, something along those lines to the officer who was givin' him commands or try, try to, tryin' to engage with him.

Detective Ryan Mitchell: It, would it be fair to say he seemed, he seemed angry?

Deputy Jaime Rodarte: Correct, right.

Detective Ryan Mitchell: And, uh, you may have mentioned this before but what time did this start, approximately ****.

Deputy Jaime Rodarte: Approximately, um, 9, 9:10, 9:15 approximately.

Detective Ryan Mitchell: So, was it dark outside or ****.

Deputy Jaime Rodarte: Correct.

Detective Ryan Mitchell: And I think you mentioned it a little bit before but, where this is at, is this a populated area in, in a city, is it more rural if you could ****.

Deputy Jaime Rodarte: It's a populated area in the city, um, basically surrounded by businesses, um, body shops, um, a lot of buildings with roll up doors, so there's a lotta cars on the street.

Detective Ryan Mitchell: Any, any residences?

Deputy Jaime Rodarte: Um, within, uh, two blocks from the location.

Detective Ryan Mitchell: And Deputy Rodarte did you, uh, ever I.D. yourself to, uh, this, this gentleman?

Deputy Jaime Rodarte: I don't believe I did, I just said at least stop 'cause he was comin' at me kinda fast and I just wanted to get his attention to stop, stop, stop I don't wanna shoot you.

Detective Ryan Mitchell: And if you, if you, um, give me approximately – how, how many, um, commands that you remember were told to ****.

Deputy Jaime Rodarte: Stop, two or three.

Detective Ryan Mitchell: By, by you specifically?

Deputy Jaime Rodarte: By me specifically.

Detective Ryan Mitchell: And collectively, uh, uh, everybody who ****.

Deputy Jaime Rodarte: Uh, it was just me and another officer at that point.

Detective Ryan Mitchell: Okay.

Deputy Jaime Rodarte: Uh, I don't think – I don't remember if he gave any commands or not, to be honest with you.

Detective Ryan Mitchell: Okay. And, when he was – you, you mentioned he, he was, uh, running towards you towards the end of this incident, is that correct?

Deputy Jaime Rodarte: Well he kinda got up quick and, uh, uh, I wouldn't say running but kind of a fast-paced walk maybe.

Detective Ryan Mitchell: So, he got up from a seated position?

Deputy Jaime Rodarte: From a knee, I believe.

Detective Ryan Mitchell: Okay

Deputy Jaime Rodarte: From like a knee, after bein' hit. Then he yelled somethin' out, um, sounded like somethin' he yelled out somethin' out in anger, um, said somethin' said came, came at me, um, and then like I said I remember seein' him raise either the left or right, I can't remember what –

Detective Ryan Mitchell: And you, you're describing you were holding it up over your –

Deputy Jaime Rodarte: Correct.

Detective Ryan Mitchell: - your head.

Deputy Jaime Rodarte: Raised his hands up over his, uh, on over his head, um, so.

Detective Ryan Mitchell: And at, at – at what – and when he got close to you, what was your thought in that moment, um, when he was, when he was approaching you?

Deputy Jaime Rodarte: He was there, he was there to commit harm to me. Obviously, he was, uh, uh, in my mind I, if, if my partner wouldn't a been there I probably woulda been stabbed, or, um, woulda been hurt seriously. Um, 'cause after I, I shot him the fourth time – I, I, I don't, I don't, I, I think I remember that I hit the trigger one more time but realized oh shit, there's no more, uh, there's no more, uh, bullets, or no more, uh, bags so I kinda retreated and, um, went for my lethal and then for a quick second I, I just remember thinkin' there's people down, down, down by the street, they're officers so I kinda broke the angle where I can, if I'd

shot him it's hit a wall or a car that was parked not, not went downhill but at that point my partner stepped in and, uh, shot him.

Detective Anthony Diehm: So, were you – you were ****, when you were braking the angle, uh, it sounds, um, it sounds like you were tryin' to create distance, buy you time and, and change your backdrop?

Deputy Jaime Rodarte: Correct. I was definitely tryin' to create distance just because I knew I had to, to change the angle, um, and I remember turnnin' my back at him at one point just to run faster so I could turn the other direction. And once I – as soon as I turned, that's when he was shot.

Detective Anthony Diehm: And during that moment, um, it sounds like you were in essence fleeing, for a moment to try and create distance and, and change the angle. Was he – he was still advancing towards you?

Deputy Jaime Rodarte: Correct and, uh, he then – that's when he got shot, um, at that point I, I, uh, threw the shotgun over my shoulder, slinged it and then I still removed my, my taser just in case 'cause I knew my partner had lethal on him again, so, and then within seconds the other officers were running down the street and, yanno, rendering CP, uh, not CPR but rendering first aide.

Detective Ryan Mitchell: And he, he was continuing to charge you after he's been struck, you said four times.

Deputy Jaime Rodarte: Four times.

Detective Ryan Mitchell: Four times –

Deputy Jaime Rodarte: Correct.

Detective Ryan Mitchell: - four times with the less lethal beanbag round?

Deputy Jaime Rodarte: Correct.

Detective Ryan Mitchell: I think we wanna take a break?

Other Speaker: I'm, I'm, I'm doin' good but yeah, we can take a break for a couple minutes.

Detective Anthony Diehm: Yeah.

Detective Ryan Mitchell: Yes.

- clarification question. So, you described he had his hands up, or his hand up over his head.

Deputy Jaime Rodarte: Correct.

What was he doing with the hand?

Deputy Jaime Rodarte: He was yellin' or mumbling somethin' and comin' at me like in an aggressive manner.

Now, you're makin' a motion with your hand, was he ****.

Deputy Jaime Rodarte: I don't ****.

Did he have anything in his hand at that point?

Deputy Jaime Rodarte: I, he, he did have somethin' in his hand. As far as what it was at that point I, I couldn't, I couldn't tell you but when he, when he fell to the ground he dropped the knife.

Okay, so, when his hand was up did he have the knife in his hand?

Detective Ryan Mitchell: The time is 0420 hours, 4:20 a.m., August 6th, 2018. This is in reference to San Rafael Case 186261 at Sonoma County Sheriff's Office, Case No. 180806002, and we are presently at the San Rafael Police Department. This is Detective Ryan Mitchell with the Violent Crimes Investigations Unit from Sonoma County Sheriff's Office. If, uh, everyone in the room could please state their name and spell their last name. All starting with my partner.

Detective Anthony Diehm: Detective Anthony Diehm with Sonoma County Sheriff's Office. Last name is D, as in David, I-E-H-M, as in Mary.

Officer Kevin MacDougald: Officer Kevin MacDougald, M-A-C- capital D-O-U-G-A-L-D. I'm an officer with the San Rafael Police Department.

Detective Ryan Mitchell: And again, it's Detective Ryan Mitchell, M-I-T-C-H-E-L-L. This is a voluntary statement. Uh, you're free to leave at any time. You're not obligated to answer any questions. Do you understand that officer?

Officer Kevin MacDougald: Yes, sir.

Detective Ryan Mitchell: As I understand it, earlier you, uh, provided a blood sample. Was that blood sample voluntarily?

Officer Kevin MacDougald: Yes.

Detective Ryan Mitchell: Uh, are you prepared to provide a statement? Have you had ample time to gather your thoughts and otherwise prepare for this interview?

Officer Kevin MacDougald: Yes.

Detective Ryan Mitchell: Do you have anything that would hinder you from giving a statement at this time?

Officer Kevin MacDougald: No.

Detective Ryan Mitchell: Has, and I know I just recently met you, uh, tonight, a few hours ago, um, do we have any type of friendship or relationship, either you and I, or yourself and Detective Diehm that would –

Officer Kevin MacDougald: None --

Detective Ryan Mitchell: -- create any sort of bias?

Officer Kevin MacDougald: None of us have ever met to my knowledge.

Detective Ryan Mitchell: Okay, Officer MacDougald, are you sick or injured?

Officer Kevin MacDougald: No.

Detective Ryan Mitchell: Did you receive any injuries as a result of the incident?

Officer Kevin MacDougald: No.

Detective Ryan Mitchell: At the time of the incident were you suffering from any medical condition or taking any medication that may have impaired your abilities as a law enforcement officer?

Officer Kevin MacDougald: No.

Detective Ryan Mitchell: When did you last sleep?

Officer Kevin MacDougald: Uh, it would've been in the morning and afternoon of the 5th, so yesterday.

Detective Ryan Mitchell: Okay. And, how long?

Officer Kevin MacDougald: About 7 hours. I think I fell asleep about 7 in the morning and got up about 2 in the afternoon.

Detective Ryan Mitchell: And when did you last eat?

Officer Kevin MacDougald: Um, 3 hours ago now.

Detective Ryan Mitchell: And, and what did you eat?

Officer Kevin MacDougald: I had a sandwich from Sole Food after the incident.

Detective Anthony Diehm: When did he eat prior to the incident?

Detective Ryan Mitchell: That's prior to the incident?

Officer Kevin MacDougald: No, this was after the incident.

Detective Ryan Mitchell: Okay, and prior to that?

Officer Kevin MacDougald: Uh, I think I had a mango after I woke up, before I came to work, but I don't remember prior to that.

Detective Ryan Mitchell: Okay. Have you consumed any alcoholic beverages in the last 24 hours?

Officer Kevin MacDougald: No.

Detective Ryan Mitchell: Officer MacDougald, how long have you worked in this, your current agency?

Officer Kevin MacDougald: Either in a full time capacity or as a reserve officer for about 42 years. Actually 2 years of that I was down at Stanford University, '77 to '79. Other than that I've been a sworn officer here, either a regular or a reserve since January of '76.

Detective Ryan Mitchell: And any, uh, special collaterals or special training, uh, firearms, SWAT, things of that nature?

Officer Kevin MacDougald: I was on the SWAT team in its infancy back in the early '80s, but other than that, uh, no.

Detective Ryan Mitchell: Any training specific to CIT, tactical communications, drugs, recondition expert, anything of that type?

Officer Kevin MacDougald: Um, I have been to DAR. I'm not a DRE. Uh, I have been to standardized field sobriety test school and standardized field sobriety test instructor school. I am a post-certified and CHP certified SFST instructor, and I've been a field training officer for most of my career. Uh, CIT and CIT updates, uh, as well as all the FTO updates.

Detective Ryan Mitchell: Okay. And your present assignment, uh, what is your present assignment?

Officer Kevin MacDougald: Assigned to patrol.

Detective Ryan Mitchell: Okay. The nature of your duties?

Officer Kevin MacDougald: Uh, general patrol.

Detective Ryan Mitchell: And what is your current, uh, work hours and shift?

Officer Kevin MacDougald: 5 at night until 5 in the morning, Thursday, Friday, Saturday nights, and then every third Sunday night including tonight, is my normal Sunday shift.

Detective Ryan Mitchell: Okay, and at what time did you start working tonight?

Officer Kevin MacDougald: 1700, 5 p.m.

Detective Ryan Mitchell: And did you have a call sign?

Officer Kevin MacDougald: Uh, my radio call sign is 3L9.

Detective Ryan Mitchell: And is this assignment a uniform or non-uniform assignment?

Officer Kevin MacDougald: Uniform.

Detective Ryan Mitchell: And specifically this assignment that you're on now, how long have you been on this assignment, specifically?

Officer Kevin MacDougald: On this particular shift with these hours or this, just –

Detective Ryan Mitchell: This particular shift with these hours working, uh, patrol?

Officer Kevin MacDougald: It's been the last 5 or 6 years.

Detective Ryan Mitchell: Okay. And the vehicle that you are assigned?

Officer Kevin MacDougald: The general, the, the vehicle that I normally drive is Unit 242. It's generally assigned to me for this patrol shift. There's no guarantees. If it's not available, it's not available to me.

Detective Ryan Mitchell: Okay, and if you could, uh, describe your uniform for me starting from the top down.

Officer Kevin MacDougald: I was wearing a, uh, LAPD blue short sleeve uniform, uh, specifically, there's a 511, Class B, uh, as in boy uniform. So it's the rip stop with cargo pocket uniforms. Uh, I was wearing a silver metal badge that contains my I.D. number. I had a silver nametag on. I had a tag above that one for the numbers 23152 on it. Um, I was wearing, I don't wear a tactical vest, I wear a regular Sam Brown type vest, or belt. I was wearing that with all of my traditional equipment on it. Would you like me to go through that?

Detective Ryan Mitchell: Uh, yeah that would be next. Uh, with the equipment as far as specifically to your belt, if you could describe that for me starting from, uh, from the middle to the right, and going around, please.

Officer Kevin MacDougald: So, middle to the right, I, I wear, I wear a nylon belt. It's not the, it's not a basket weave. It is a nylon belt. Um, to my immediate right of the belt buckle would be, the first thing is actually my, uh, sidearm, on my right side. Behind my sidearm is my, uh, collapsible ASP baton. Then I have two single cuff, handcuff cases that I wear generally in the middle of my back. Uh, to the right, to the next going around is my, uh, portable radio. Uh, next to my portable radio would be my magazine pouches. I don't carry OC spray. And that's it.

Detective Ryan Mitchell: And description caliber of your firearm?

Officer Kevin MacDougald: It's a Colt 1911 Model 45 caliber handgun.

Detective Ryan Mitchell: Any backup guns?

Officer Kevin MacDougald: No.

Detective Ryan Mitchell: Any other firearms in your vehicle?

Officer Kevin MacDougald: Yes.

Detective Ryan Mitchell: And what are those?

Officer Kevin MacDougald: Uh, there's an M4 .223 carbine, and then there's a Remington 870 Wingmaster, uh, shotgun with less lethal beanbag rounds in it.

Detective Ryan Mitchell: And at the time of the incident, did you have a body worn camera or an audio recorder?

Officer Kevin MacDougald: Yes.

Detective Ryan Mitchell: Both?

Officer Kevin MacDougald: No, just, well, I wearing a body worn camera that's audio and digit-, and video.

Detective Ryan Mitchell: Okay, and did you have an electronic control device, or otherwise known as a Taser on your person?

Officer Kevin MacDougald: Oh, yes, I did, I'm sorry. It's that one.

Detective Ryan Mitchell: And that was on your belt?

Officer Kevin MacDougald: Yes. My left side next to my radio.

Detective Ryan Mitchell: Any other equipment that you, that is relevant?

Officer Kevin MacDougald: Uh, I had a folding knife in my back pocket.

Detective Ryan Mitchell: Okay. Okay the nature of this investigation concerned is, concerns a significant incident you were recently involved in. It occurred in the general area of Market and Verdi Street in San Rafael. Uh, please describe the event in as much detail as you can. Include the time of the event, names of witnesses, names of officers as best as you can recall. Include all the information you can remember relative to the circumstances.

Officer Kevin MacDougald: The event began when Corporal Peombo advised over the radio that he needed personnel assistance behind Burger King because he had a subject that was waving knives. I don't remember if in that initial con-, in that initial broadcast he said he was not responsive. Subsequent to that, uh, other officers began arriving there. I was still in the downtown area, and then they asked for additional officers after that. I responded from the area of 4th and, 4th Street at Luten's, uh, Code 3. While I was driving I was asked to take a position on Belvedere Street at Verde Street to block off Verde Street from vehicle and pedestrian traffic. Uh, I got there. I took that position for a short period of time by myself, and then a deputy, Marin County deputy sheriff arrived, and at various times we relocated our cars to block off not just Verde Street, but Belvedere Street in both directions to vehicular traffic. Uh, we were paying attention to both vehicular tra-, traffic, pedestrian traffic that was walking. We were aware that, that the incident was active in the intersection of Verde and Market Street, which was maybe a hundred yards away from my position. Uh, the deputy and I watched and listened while the events were unfolding. Uh, at various times I was listening to radio traffic. Um, the radio traffic that I recall was that the subject had, was waving knives in both hands, that he was non-compliant with orders, and that he was yelling at, at least at one point he was yelling that he wanted the police to shoot him. That was all radio traffic that I heard. Uh, I could hear Officer Garrisons giving him, or engage, trying to engage with him verbally. I could see the subject walking generally in circles in the intersection of Verde and, uh, Lisbon Street. And then immediately before the incident the subject disengaged with the officers that were talking with him at that intersection. He turned his back to them and started advancing, uh, toward myself and the deputy. Um, I saw that occurring. I asked if the dog could be released. I advised over the radio that there was only two of us in that position, that we needed more officers. The subject kept advancing. The deputy, and I'm sorry I wish I knew his name so I could personalize this, uh, told this, yelled at the subject to stop advancing, advised him that he would – remember his exact, I don't remember the exact warning that he gave. Uh, he, he then yelled less lethal several times, and fired four rounds from, uh, his shotgun. It contained less lethal beanbags in it. After the third or f-, after the third shot and during the fourth shot, the subject, um, stood up, or straightened up, started screaming, and started running at the deputy, flailing with both hands with what I understood to be knives in both hands. I stepped into the street from kind of a position that I was standing in which was next to a, or behind a small pickup truck that was parked. Uh, as I did that the subject, I don't think he paid attention to me prior to that, but he turned to look at me. Uh, I could see that he was flailing with knives. He was not compliant. I was concerned that he was, he was attacking the deputy. I was concerned that he was going to attack me. When that happened I fired one shot from my handgun. I could tell that it hit him. It doubled him over. He bent down a little bit. He began to straighten up so I did not incapacitate him. Uh, when he started to stand up I fired two more rounds from my handgun, uh, and he fell to the ground.

Detective Ryan Mitchell: Okay. I'm just gonna have a couple of follow-up questions. Um, did anything happen after he fell to the ground?

Officer Kevin MacDougald: He was immediately, uh, provided with First Aid by a number of officers that ran up to him. I actually stood, stepped back so I didn't engage with him further.

Detective Ryan Mitchell: Okay. And backing up a little bit, towards the beginning you mentioned when you responded, you responded Code 3, and, and can you define what Code 3 is?

Officer Kevin MacDougald: I activated all of my, uh, strobe emergency lights and siren.

Detective Ryan Mitchell: Have you kind of, this, this area, if you could kind of describe it to me. Um, the, the approximate time of this incident was?

Officer Kevin MacDougald: It began somewhere after 9 p.m., 2100 hours, somewhere, so maybe 2110 hours, 9, 9:10. Uh, the scene is, uh, an odd shaped, a couple of odd shaped streets. Uh, there is a Burger King restaurant that kind of forms the base of it, uh, and all of this is generally occurring toward the back, what I would call the back of the Burger King parking lot and the, and the intersection next to it. Uh, other than the Burger King almost all of the adjacent businesses are auto repair shop businesses, uh, that are not open at that time on a Sunday night. Burger King is. So it's an industrial, light industrial area, mostly comprised of auto repair shops and the Burger King.

Detective Ryan Mitchell: And, and the lighting, officer? How, how was the lighting? Was it, was it dark, light out?

Officer Kevin MacDougald: The lighting, well it was night time, it was well after dark, even at this time of year. Uh, my recollection is surprisingly that there was a lot of light right where we were standing. I, I think back, I don't know if it's bright overhead street lights. If it was a reflection of our vehicle lights, uh, but, but it was actually a well-lit area for that time of night.

Detective Ryan Mitchell: And were there other people in the area?

Officer Kevin MacDougald: I was not able to determine how many officers were at the other end of the street engaging with him or-, originally. Um, at my end of the street there was myself and the Deputy Sheriff and then there were a number of, uh, bystanders who were off to the side on both sides of the street. I couldn't tell you how many.

Detective Ryan Mitchell: Okay. And did you, did you know the suspect?

Officer Kevin MacDougald: No.

Detective Ryan Mitchell: Can you describe him to me please?

Officer Kevin MacDougald: A male. That's as good as I'm gonna get.

Detective Ryan Mitchell: Okay. And as I understand it, you heard on the radio that he had knives, is that correct?

Officer Kevin MacDougald: Yes.

Detective Ryan Mitchell: Did you ever see them yourself?

Officer Kevin MacDougald: Yes.

Detective Ryan Mitchell: Okay. At what point did you first see that the suspect was, was armed with knife or knives?

Officer Kevin MacDougald: He went, as he was advancing toward me I could see items clenched in each of his hands based on all of the information that I had I understood that those were knives.

Detective Ryan Mitchell: Okay. And if you could describe how, um, the suspect was holding the knives when you first saw him.

Officer Kevin MacDougald: Best of my recollection just holding them, I don't know how to describe it, in this manner. So he was holding –

Detective Ryan Mitchell: Okay, you're, you're holding your left hand up and you have glasses, and you're holding like in a stabbing motion with your left hand –

Officer Kevin MacDougald: **** stab. Correct.

Detective Ryan Mitchell: – and your right hand the same.

Officer Kevin MacDougald: Correct. He was not, he was not holding them with his palms up, and what expert knife fights might look like, he was holding them where in this, in a slashing or stabbing maneuver.

Detective Ryan Mitchell: His, his hands were, you're hold about, about head level, shoulder level –

Officer Kevin MacDougald: I mean –

Detective Ryan Mitchell: – approximately that?

Officer Kevin MacDougald: He was holding them, he was holding them mid chest level as he was advancing. After he was shot with the bean bags his hands went up and he, as if he, and started to flail, and he was yelling and started running toward the Deputy Sheriff.

Detective Ryan Mitchell: You mentioned yelling, do you remember what he yelled?

Officer Kevin MacDougald: No. I have no idea.

Detective Ryan Mitchell: Do you remember any specific things that were said to him from either yourself or other law enforcement officers?

Officer Kevin MacDougald: I told him to stop at least once. I know the Deputy Sheriff yelled at him, gave him commands to stop. I don't remember exactly what he said, but it was a command to stop, and it, and I believe it included a threat that he was going to be shot or hurt if he didn't.

Detective Ryan Mitchell: Do you know if the less lethal device as you described it, uh, struck the suspect?

Officer Kevin MacDougald: Yes I believe that all four beanbags hit him.

Detective Ryan Mitchell: And you said after that he advanced is that correct?

Officer Kevin MacDougald: The first shot hit him, and he kind of turned away for a s-, for a fraction of a second. He straightened up, squaring up again at the deputy sheriff who was standing maybe 20 feet away from me. The next three rounds, or the next two rounds he didn't advance. After the third round he started advancing rapidly. I'll call it running toward the deputy. The deputy fired the fourth round which did not have any affect, uh, at that point the deputy was out of, uh, his shotgun was empty. He started retreating and the subject started running, continued to run at the deputy with his arms flailing and screaming.

Detective Ryan Mitchell: You said his arms were frailing, is he, is he moving at this point? His, his arms are, are moving?

Officer Kevin MacDougald: He was running or he sped up, and I know run can be relative, but he was screaming, he was running at the deputy and he holding his hands and his hands were going, were wind milling –

Detective Ryan Mitchell: You're, you're describing wind milling or moving, your arms back and forth, in the same, that same stabbing motion you were showing early.

Officer Kevin MacDougald: Yes. He was – yes.

Detective Ryan Mitchell: And when, when he started, uh, as you described it, running, running, he, he wasn't walking, is that correct?

Officer Kevin MacDougald: He was not walking, and he was going faster than any of the movements that I had seen, or seeing that my impression was that he started running at the deputy.

Detective Ryan Mitchell: Understood. When he ran towards the deputy what, what was your, uh, thought process at that time?

Officer Kevin MacDougald: He was attacking the deputy. The deputy had, was backing away because he no longer had, uh, a functional weapon in his hand, and so I, I moved from my position toward him. Uh, I think, I, I, I don't know what went through his mind, but he turned, he turned toward me so I assumed that he saw the movement and turned toward me, uh, and I believe that he was going to attack me at that point.

Detective Ryan Mitchell: Okay, backing up to where the deputy, what did you see the deputy do in response to the suspect advancing towards him?

Officer Kevin MacDougald: He started backing up.

Detective Ryan Mitchell: Okay. And did he, was he walking backwards, did he turn and run? Uh, can you describe that please?

Officer Kevin MacDougald: He started backing up. My impression is that he actually turned his back at one point, but I can't be positive of that, but he was, he had exhausted his, the weapon that he had in his hands. He didn't, he was still holding the shotgun. He didn't drop it. He didn't go to a different weapon system. Um, and I, and I believe that the subject was, uh, was intensing, attacking. I couldn't, I was watching the subject, I was not watching the deputy.

Officer Kevin MacDougald: I saw him backing away, but I didn't focus on him.

Detective Ryan Mitchell: Understood. And you mentioned the suspect turned towards you at one point, is that correct?

Detective Anthony Diehm: Okay, and during that time, um, could see what the suspect was doing?

Officer Kevin MacDougald: I could see at limited times the way that, the way the other police vehicles were positioned, there was at least one patrol car that was pointing directly at me. Uh, that patrol car had all of its takedown and alley lights on, which it was really bright, so when I looked straight down to that, to the intersection all I could see generally was those lights, the police vehicle lights, until he, at times he, my impression was that he was walking around in oval-type circles in front of the patrol cars engaging with all of the officers that were there, but I could see him walk, my impression was it was like an oval circle back and forth in that intersection that I described, but I couldn't see everything, I could only see him when he kind of got away from the central part of this takedown lights.

Detective Anthony Diehm: Okay. Jumping forward, the, uh, in your career, have you ever, either yourself, or observed another law enforcement officer fire a, uh, for lack of better term, bean bag shotgun, uh, what, whether, uh, whether in a real life scenario or in just in training?

Officer Kevin MacDougald: Yeah, so, I've, I have not been present in a field shooting, but we've all, I've received training with the beanbag shotgun, uh, and I've been present when, you know, hundreds of rounds of beanbags have been fired on the training range.

Detective Anthony Diehm: Okay. And based on that exp-, your training and that experience of saying hundreds of rounds fired, um, do you have expectation of the, the effects of being hit with a beanbag round, after seeing, after seeing rounds fired, do you have an expectation of what you think would happen if a person's hit by a beanbag round?

Officer Kevin MacDougald: No, I've only seen them fired at paper targets. Um, I've heard anecdotal stories, um, you know, from different people, but I didn't have necessarily any, any expectation of what was going to happen.

Detective Anthony Diehm: Well I guess what I'm trying to ask is based on what you've seen, seeing the rounds being fired at paper targets, if you yourself was hit with a beanbag, bag round from a shotgun, uh, do you think it would hurt?

Officer Kevin MacDougald: I can't tell you.

Detective Anthony Diehm: You can't tell. Okay. Um, as, as the subject was running at the deputy, with what you described as the, uh, knives raised, did you have any feeling as to, um, what might happen if the subject didn't stop?

I operated the total station and ranger while Sgt. Berringer "walked" the scene with the prism pole. A reference measurement protocol was followed whereby two independent measurements were taken to a known distance using a steel tape measure. One was taken at the start of electronic mapping, and another at its conclusion. This was done to verify "acceptable accuracy" levels for both distances and angles.

After the necessary points were collected, I downloaded the file into the Crime / Crash Zone software so I could complete the attached factual diagrams. Sgt. Berringer had also provided me with the physical evidence measurements collected on the actual date of this incident.
